IATA Multilateral e-AWB Agreement (Presented by IATA)

國際航空運輸協會多邊電子提單協議

- What is an e-AWB: electronic contract of carriage between forwarder and airline 什麼是電子提單:貨運代理與航空公司之間的運輸電子合同
- 2 ways of IATA proposed e-AWB handling:

IATA 提出兩種處理電子提單的方式:

forwarders submit air waybill information (FWB) through their own system which is directly connected (host-to-host) with airlines' system to exchange shipment status update (RCS) in IATA Cargo-IMP or IATA Cargo-XML format

貨運代理可透過自己的系統與航空公司的系統直接連繫(主機對主 機),並根據國際航空運輸協會的 Cargo-IMP 或 Cargo-XML 格式互換 最新貨運狀況(RCS)

- forwarders submit FWB and receive status update (RCS) through a 3<sup>rd</sup> party portal eg EzyCargo or airlines' official website 貨運代理可經由第三方平台如 EzyCargo 或航空公司的官方網站提交 FWB 及接收最新貨物狀況(RCS)
- Options for e-AWB agreement

電子提單協議之選擇

through an e-AWB portal: forwarder accepts the terms and conditions for the carriage (equivalent to the EDI e-AWB agreement) 通過電子提單平台:貨運代理可接納承運的條件及規定(相等於 EDI 電子提單協議)

- o through direct host-to-host with airline system: a bilateral or multilateral agreement will be signed between forwarder and airline 透過與航空公司系統進行直接連繫:貨運代理與航空公司可簽署雙邊 或多邊協議
- o IATA recommended approach: multilateral e-AWB agreement, more from IATA 倡議:多邊電子提單協議,欲知詳情,請參閱 http://www.iata.org/e-awb-multilateral
- Benefits to freight forwarders to adopt e-AWB 應用電子提單為貨運代理帶來的好處
  - o Increase productivity (reduce human errors, no need to line up at airlines' counters) 提高生產力(如減少人為錯誤,並無需於航空公司櫃檯排隊輪侯)
  - Improve customer service (handle urgent shipments with ease) 提升客戶服務質素(如輕鬆處理緊急貨件)
  - Reduce costs (no storage, no need to purchase neutral AWB) 降低成本(如無需儲存及購買提單)
  - Increase information quality (data integrity and completeness) 提高數據的準確和完整性

Beyond e-AWB - Meeting Upcoming e-Security Requirements (Presented by GLS) 除電子提單以外-世界各地的電子保安規定亦與業界息息相關,如美國,加拿大和歐盟

HKG –Regulated Agent Regime 香港-RAR

> From 15 Jul 2013, the adherence to the new ICAO air cargo security standards will necessitate, inter alia, the extension of the application of the RAR to cargo carried on all freighters.

遵照國際民航組織 (ICAO)頒布從 2013 年 7 月 15 日起適用的新修訂空 運貨物保安標準,香港的空運貨物保安管制代理人制度將予以強化。 其中一項修訂,是把管制代理人制度擴展至以全貨運航機運載的貨物

- Roadmap of e-security requirements by major import countries 各主要進口國之電子保安概定指引
  - US ACAS (Air Cargo Advance Screening) 美國 - ACAS
    - 6 mandatory data elements (piece, weight, origin & destination, goods description, shipper name & address, and consignee name & address) are required 6 種資料事項必須填寫(件數,重量,原產地及目的地,貨物 描述,發貨人名稱及地址,收貨人姓名和地址)
    - to submit 2 hours before flight departure 並需於航班出發 2 小時前提交
  - Canada PACT (Pre-Load Air Cargo Targeting) 加拿大 - PACT
    - assessment and requirement development underway 當中評估和需求正在開發中
  - EU Air Cargo or Mail Carrier Operating in the European Union from a Third Country Airport

歐盟 - ACC3

- an audit to obtain an EU Aviation Security Validation 需經過審核並獲得歐盟航空安全驗證
- by independent validator from 1<sup>st</sup> July 2014 並於 2014 年 7 月 1 日起需由獨立認可機構處理

From e-AWB to e-Freight: The Community e-Platform in Hong Kong (Presented by Tradelink)
